

TERMS AND CONDITIONS OF HIRE

The Client agrees to the following TERMS AND CONDITIONS OF HIRE and the OCCUPATIONAL HEALTH AND SAFETY RISK ASSESSMENT when hiring the equipment from Shayden Limited trading as Golf2Go. When an enquiry or subsequent booking is made by the Client, the Client will be emailed this contract. The Client has five working days to notify Golf2Go in writing if the Client wishes to cancel any requested bookings without penalty.

It is deemed that the Client has accepted these TERMS AND CONDITIONS OF HIRE if no further correspondence is entered into.

Important note:

- **The client accepts that a minimum charge of \$95 plus GST will be incurred if the equipment hired is not returned in a clean and dry state and repackaged in the correct bags in which it was received. In particular, if the greens are used on outdoor surfaces such as grass, it is the Hirer's responsibility to clean and dry the greens before collection. All obstacles and equipment must be inserted into their respective packaging.**

The Client:

- shall pay the TOTAL COST of hire at least 8 working days prior to the HIRE DATE. The TOTAL COST will be refunded if the Client provides at least 7 days cancellation notice prior to the HIRE date. Any cancellations less than 8 working days prior to the HIRE DATE shall be charged the full freight costs of the agreed hire plus 25% of the HIRE COST of the greens.
- **Covid 19** - if the government imposes alert level 2, 3 or 4 after the golf has been shipped, Golf2Go **may** allow the greens to be retained by the hirer until alert level 1 is reinstated. If this takes place, no additional costs will be incurred for the extended period of hire. If the hired equipment is required by Golf2Go elsewhere, the client must make the equipment available for return freight. The client shall be charged the full freight costs of the agreed hire and in return, Golf2Go will offer the freight portion (previously charged), as a credit on the next proposed hire period. This freight credit will be valid for a period of 12 months from the original proposed date of hire. Any Equipment hire costs paid by the client, prior to an alert level increase, can be refunded in full providing the equipment is returned without being used due to cancellation of such events that the equipment was hired for.
- shall be charged 3% interest per month in addition to any unpaid amounts outstanding after the HIRE DATE and hereby accepts that they shall be liable for all legal costs in the event of Golf2Go being required to institute action for recovery of the TOTAL COST of hire, the equipment, the value of replacement of the equipment or for collection of charges, and the Client acknowledges that they shall be liable for interest on those amounts.
- hereby ensures the LOCATION OF HIRE for the equipment is on a clean, firm, flat grassed or solid surface and has read and followed the 'OCCUPATIONAL HEALTH AND SAFETY RISK ASSESSMENT' schedule. The Client must provide a suitable and safe environment for the equipment and its users.
- hereby accepts that Golf2Go has offered the equipment in proper working order, fit for use as intended by the Client and indemnifies Golf2Go against any claims which may be made against it by any person during the HIRE TERM.
- hereby ensures no person shall play on the equipment with sharp objects, drinks or food and ensures no smoking on or near the equipment at all times and ensures all greens, balls, putters and any other equipment hired, are used with care and for their intended purpose only.
- hereby ensures the equipment is under the strict supervision of a responsible adult at all times and agrees to follow any verbal instructions given at the time of installation and collection of the equipment.
- hereby accepts responsibility for the loss, theft or damage to the equipment and injury to any person/s resulting from the use of or operation of the equipment. Loss, theft or damage to the equipment WILL result in the Client paying full replacement costs.
